- A. Adoption of the Nonresident Tuition Fee for 2018-19. The proposed Nonresident Tuition Fee of \$214.00 per semester unit for a 30 unit semester term academic year is based on the district average cost option 2 fee per unit. The proposed rate results in a \$3.00 (1.4%) increase over the current rate of \$211.00 per unit and is projected to increase local revenues by \$19,000.00 and will be deposited into GU001 Unrestricted funds. The fee will be per unit, up to and including 15 units, and will be effective beginning the summer session of 2018.

- A. Adoption of the Nonresident Tuition Fee for 2017-18. The proposed Nonresident Tuition Fee of \$212.00 per semester unit for a 30 unit semester term academic year is based on the contiguous district option 4 (State Center CCD) fee per unit. The proposed rate results in a \$1.00 (0.47%) increase over the current rate of \$211.00 per unit

and is projected to increase local revenues by \$5,400.00 and will be deposited into GU001 Unrestricted funds. The fee will be per unit, up to and including 15 units, and will be effective beginning the summer session of 2017.

- B. Adoption of the Nonresident Capital Outlay Fee for 2017-18. The proposed Nonresident Capital Outlay Fee is \$0.00 per semester unit. This fee is optional and due to the passage of Measure J the need for the Capital Outlay fee has been significantly reduced. The proposed rate results in a \$21.00 per unit decrease in fees to non-resident students. The change in the fee is projected to decrease local capital outlay revenues by \$115,000.00.
- C. Authorization for the Chief Financial Officer to enter into an independent contractor agreement between the Kern Community College District, on behalf of Bakersfield College, and the RP Group to provide research and technical assistance relating to Bakersfield College's current research evaluation efforts. The term is from August 1, 2016 through June 30, 2017. The cost to the District is not to exceed \$110,750.00, to be paid from RP382 Student Equity Restricted Program fund.

Authorization for the Chief Financial Officer to execute Amendment 01 to Contract CSPP-6114 California State Preschool Program between the Kern Community College District, on behalf of Bakersfield College, Cerro Coso Community College, and Porterville College, and the State Department of Education. With no change to the term, the increase in the amount payable to the District is \$74,836.00, to be deposited into CD004 State Preschool funds.
